Some examples are, "2 Muddy", "2 Bike", "2 Drive", "2 Hunt", etc. Our designs are created with lifestyle in mind. We offer unique colors to add to your pre-existing T-shirt or softgood categories. With our style and connection to youth and active adults alike, we feel that our exciting new look will tap into the younger market as well as the young at heart. Our goal is to build a personal relationship with our retailers and increase their gross sales while growing brand recognition of 2wear™ Apparel.

ORDERING

- There is a minimum first order of four (4) dozen per design for all new accounts, NO MIXING. No minimums for existing accounts.
- Any cancellations must be made in writing (or faxed) within (2) days of submission of PO from retailer.
- All orders, and or credit applications are subject to the approval of Palo Creative, PLL and may be rejected without liability or cause.

TERMS

- Net 30 upon credit approval. 2% Net 10 may be negotiated with some retailers.
- First time orders must be paid with credit card, check or money order. No C.O.D.
- Credit limits will be based on payment patterns and past sales volumes.
- Credit card payments accepted. Credit card payment due prior to shipping products. We welcome - MASTERCARD/VISA/DISCOVER/AMEX.
- Accounts past due will automatically be placed on credit hold. No existing orders will be shipped until all overdue amounts are paid.
- A finance charge of (1.5%) per month will be applied to overdue accounts.
- Accounts more than (90) days past due may be turned over for collections.
- Customer agrees to pay all charges incurred by the collection efforts of Palo Creative, PLL and that Youngstown, OH will be the legal venue if litigation is commenced by either party.

FREIGHT

- All shipments will be sent UPS Ground unless otherwise stated, F.O.B. Youngstown, Ohio.
- All shipping, handling and insurance charges, if applicable will be added to each shipment.

DAMAGED, INCORRECT, OR LOST SHIPMENTS

- No returns accepted or claims allowed after receipt of goods, unless there are damaged goods on a per item submission.
- Please report packing errors within (3) days of receipt of your order. We will either replace missing goods or issue a credit for those goods.
- (RA) Return authorizations are void after (12) days of date issued.
- No handling, warehouse, or distribution charges will be accepted.
- We reserve the right to either repair or replace damaged goods. If we are unable to do so we will issue a credit.

MISCELLANEOUS

- Terms, conditions, and prices are subject to change.
- Accounts will be charged \$30 for each returned check.
- All sales are final. No cash refunds allowed.
- Credits are for purchase of merchandise only.
